OQ Program Assessment

A Veriforce consultant assesses your company's OQ program utilizing PHMSA OQ rules/protocol to determine adherence to 49 CFR 192 and/or 195 and to appraise the effectiveness of your OQ program. It typically requires 1-3 days and includes interviews with personnel who have OQ responsibilities, a review of qualification records for personnel who perform covered tasks, and a recordkeeping review (O&M activities, project files, etc.).

O&M Program Assessment

Through on-site and/or off-site review, our compliance specialist evaluates your O&M program against the requirements of 49 CFR 192 and 49 CFR 195 (following established inspection criteria based on PHMSA O&M inspection forms) and/or state regulations. Deliverables include, but are not limited to, an executive summary report, recommendations, and a detailed review of all areas assessed.

HQ D&A Program Assessment

A Veriforce consultant assesses your company's D&A program, utilizing DOT/PHMSA D&A protocol to determine adherence to 49 CFR 40 and 199 and to appraise the effectiveness of your program. Our assessment includes interviews with personnel who have D&A responsibilities, as well as a review of your written D&A plan, employee assistance program (EAP), D&A recordkeeping, and program to manage your contractors' DOT/PHMSA D&A compliance. CRM Program Assessment

Following PHMSA CRM inspection form guidelines, a Veriforce compliance specialist performs a review to evaluate your CRM program's compliance with the requirements of 49 CFR 192.631 and/or 195.446. Our consultant's review of your program may include: evaluation of the need for a CRM program, controller roles and responsibilities, adequate information development, measures to mitigate fatigue, alarm management strategies, management of change processes, controller training, and required documentation. Our team conducts interviews of off-duty controllers, SCADA technicians, and control room supervisory personnel as appropriate to aid in the assessment.
